GENERAL: CLEANSE a highly complex designed surfactant, aiding golf course superintendent and other turf managers a comprehensive, active approach to the causes and problems associated with soil water repellency. CLEANSE represents a new model in the direction of providing a reprieve from localized dry spots, poor infiltration and non-uniform water movement into the root zone. CLEANSE concentrated solvent addresses the progressive build-up of water repellent organic coatings found on soil particles. CLEANSE is safe on fine turf, no negative effects have ever happened to turf when applied according to label directions. Recommended for golf courses, athletic fields, tennis, lawn bowling and other grass sporting fields.

DIRECTIONS FOR USE: Greens, Tees, Fairways, Athletic Fields, Tennis, Lawn Bowling, Lawns, Parks and other Sports Turf.

Localized Dry Spot and Water Repellency Conditions:

Treatment: Apply CLEANSE at 6 fl. oz. per 1000 sq. ft. in 2 gallons of water spray solution. Repeat application 14 day later at 6 fl. oz. per 1000 sq. ft. in 2 gallons of water. In extreme situations a third application maybe considered. Once soil has been mediated, apply CLEANSE or THE KRAKEN every 30 days as a preventive strategy.

MAINTENANCE: Apply CLEANSE at 6 fl. oz. per 1000 sq. ft. in 2 gallons of water spray solution. Reapply every 30 days at 6 fl. oz. per 1000 sq. ft.

CLEANSE is safe on all turf types and can be used on tine turf for golf courses, athletic fields, tennis, lawn bowling, sporting fields, lawns, parks as well landscape.

Tank Mixing: CLEANSE may be tank mixed with other commonly used turf chemicals and fertilizers at rates not to exceed 6 fl. oz. per 1000 sq. ft. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, CLEANSE should be tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Tank mixing CLEANSE and other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.
