Golf Greens / Tees (14- day program)	First Application: 3-5 oz /1000ft ² Every 14 Days: 1.5- 2 oz /1000ft ²
Golf Fairways / Athletic Fields	Every 30 days or as needed: 5 oz /1000ft ²
Lawn Care and Landscapes	Every 30 days or as needed: 5 oz /1000ft ²

DIRECTIONS FOR USE:

SHAKE WELL BEFORE USING

Preventive Program: Apply 3-5 fl oz. of INFINITE per 1000ft² in 2 gallons of water (88 mL/148 m2 in 8 L of water). Reapply 3-5 fl oz. per 1000 sq. ft every 30 days as long as symptoms prevail.

Curative Program: Apply 5 fl Oz. of INFINITE per 1 1000ft² in 2 gallon of water every 7 - 10 days until LDS symptoms subside.

Irrigation should be applied before next mowing, so not to remove any material

Biweekly Program: Apply initial application of INFINITE at 5 fl oz. of per 1000ft² in 2 gallons of water (148 mL/100 m2 in 8L of water). After initial applications, apply biweekly at 15-2.0 fl oz. per 1000ft² (44-59 mL/100 m2 in 8L of water). Initial 5 fl oz. per 1000ft² application are critical in maintaining a biweekly program.

Tank Mixing: INFINITE may be tank mixed with other commonly used turf chemicals and fertilizers at rates not to exceed 6 oz per 1000ft². If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, INFINITE should be jar tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Tank mixing INFINITE and other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.
