PREVENTIVE PROGRAM:

DISTANCE should be applied in 2 applications. Apply first application at 8 fl. oz. per 1,000 sq. ft. Apply second application

14-60 days later.

Under 2 split applications, DISTANCE should be sprayed at 8 fl. oz. per 1,000 sq. ft. and should be applied in 2 gallons of water per 1,000 sq. ft. spray solution.

Multiple applications techniques:

-Apply first application at 8 fl. oz. per 1000 sq. ft. with 2 gallon spray solution per 1000 sq. ft. Apply second application at or around 60 days at 4 fl. oz. per 1000 sq. ft. with 2 gallon spray solution. Repeat at 4 fl. oz. per 1000 sq. ft. with 2 gallon spray solution, every 30 days until condition is relieved or season is concluded.

-Apply first application of 6 fl. oz. per 1000 sq. ft. with 2 gallons spray solution per 1000 sq. ft. repeat applications of 4-6 fl. oz. per 1000 sq. ft. in 2 gallons spray solution every 30 days.

DISTANCE is safe on all turf types and can be used on fine turf for golf courses, athletic fields, tennis, lawn bowling, sporting fields as well lawns/landscape.

Tank Mixing: DISTANCE may be tank mixed with other commonly used turf chemicals and fertilizers at rates not to exceed 8 fl. oz. per 1000 sq. ft. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, DISTANCE should be tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Tank mixing DISTANCE and other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.

PRECAUTIONARY STATEMENT
