SUGGESTED APPLICATION RATES

At the recommended rate, this bag will cover between 8,000 square feet and 13,330 square feet of greens or tees.

GREENS AND TEES (medium rate):

6.25 lbs. per 1,000 square feet applies 0.50 lbs. N per 1,000 square feet, equivalent to 272 lbs. per acre (5.4 bags).

GREENS AND TEES (low rate):

3.75 lbs. per 1,000 square feet applies 0.30 lbs. N per 1,000 square feet, equivalent to 163 lbs. per acre (3.26 bags).

WATER IN THOROUGHLY AFTER APPLICATION.

Always use caution when fertilizing golf course greens, especially greens exposed to heavy play and warm weather.
