

SUGGESTED APPLICATION RATES

At the recommended rate, this bag will cover between 7,990 square feet and 15,970 square feet of greens or tees.

GREENS AND TEES (medium rate):

6.26 lbs. per 1,000 square feet applies 1 lbs. K_20 per 1,000 square feet, equivalent to 273 lbs. per acre (5.5 bags).

GREENS AND TEES (low rate):

3.13 lbs. per 1,000 square feet applies 0.50 lbs. $\rm K_20$ per 1,000 square feet, equivalent to 136 lbs. per acre (2.7 bags).

WATER IN THOROUGHLY AFTER APPLICATION
