At the recommended rate, this bag will cover between 11,410 square feet and 15,970 square feet of greens or tees.

**GREENS AND TEES (medium rate):**  
4.38 lbs. per 1,000 square feet applies 0.7 lbs. N per 1,000 square feet, equivalent to 191 lbs. per acre (3.8 bags).

**GREENS AND TEES (low rate):**  
3.13 lbs. per 1,000 square feet applies 0.50 lbs. N per 1,000 square feet, equivalent to 136 lbs. per acre (2.7 bags).
