SUGGESTED APPLICATION RATES

At the recommended rate, this bag will cover between 11,300 square feet and 17,000 square feet of greens or tees.

GREENS AND TEES (medium rate):

4.41 lbs. per 1,000 square feet applies 0.75 lbs. N per 1,000 square feet, equivalent to 192 lbs. per acre (3.8 bags).

GREENS AND TEES (low rate):

2.94 lbs. per 1,000 square feet applies 0.50 lbs. N per 1,000 square feet, equivalent to 128 lbs. per acre (2.5 bags).
