**SUGGESTED APPLICATION RATES**  
At the recommended rate, this bag will cover between 10,000 square feet and 20,000 square feet of greens or tees.

**GREENS AND TEES (medium rate):**  
5.0 lbs. per 1,000 square feet applies 1 lbs. K<sub>2</sub>O per 1,000 square feet, equivalent to 218 lbs. per acre (4.4 bags).

**GREENS AND TEES (low rate):**  
2.5 lbs. per 1,000 square feet applies 0.50 lbs. K<sub>2</sub>O per 1,000 square feet, equivalent to 109 lbs. per acre (2.2 bags).

**WATER IN THOROUGHLY AFTER APPLICATION**  
Always use caution when fertilizing golf course greens, especially greens exposed to heavy play and warm weather.
